

## Forest Management Certification Assessment of GCF US Holdings, LLC in Memphis, TN, USA

## **September 25, 2025**

**Introduction** – Preferred by Nature is conducting Forest Management and Chain of Custody certification assessments of the **GCF US Holdings**, **LLC** located in **Memphis**, **TN**, **USA**. The assessment will be implemented from November 3-7, 2025.

Scope of the Certification Assessment – The forest management certification assessment will assess the environmental, silvicultural and socioeconomic aspects of the GCF US Holdings, LLC of 24 properties located in Alabama, Georgia, Mississippi, North Carolina and Virginia, totaling approximately 109,510 hectares, using the FSC-US Forest Management Standard (v1.1) and the FSC Standard For Group Entities in Forest Management Groups (FM-STD-30-005). Please note that the standard may be modified to take account of stakeholder comments. Preferred by Nature is accredited by the Forest Stewardship Council™ (FSC™), and this assessment process must follow procedures which have been approved.

Assessment Team Composition - The assessment team will be led by Randy Coots.

**Assessment Steps and Schedule** – Following is a short description of the certification process and a tentative agenda:

- Assessment organization Preferred by Nature team will assemble in Columbus, MS, November 3, 2025.
- Field assessments The team will visit sites managed by GCF US Holdings, LLC from November 3-6, 2025.
- <u>Stakeholder consultation</u> Throughout the fieldwork, the team will contact local stakeholders regarding GCF
   <u>US Holdings</u>, <u>LLC</u> forest management in villages surrounding the forest area. This will include private interviews and discussions, and public stakeholder meetings.
- <u>Final assessment briefing</u> Prior to departure the team will meet with **GCF US Holdings**, **LLC** managers and other parties to finalize their data collection and present preliminary findings.
- <u>Draft report production</u> The assessment team will produce a confidential draft report that will be circulated for comment to GCF US Holdings, LLC and an independent peer reviewer. This should occur 45 days after completion of the assessment.
- <u>Certification decision</u> Upon receipt of comments on the draft report from GCF US Holdings, LLC forest
  managers and independent peer reviewers, and other general stakeholder comments, PbN will reach a
  certification decision. Barring unforeseen obstacles, this should occur by January 1, 2026.

Your Input Sought – As a part of the forest certification assessment process we invite stakeholders to offer comment and feedback on GCF US Holdings, LLC forest management in relation to conformance with the requirements of the forest management standard referenced above as well as comments on the FME's management and protection of High Conservation Values within the forest under evaluation. We welcome input, either public or confidential, in whatever form is easiest and most secure for you. Your input will be valuable at

any stage of the assessment process, but we would prefer to receive your comments either prior to the assessment, during the assessment, or prior to November 15, 2025, so that we can take them into consideration in reaching a certification decision by January 1, 2026. Your options for communicating your observations to us are as follows.

- 1. Meet with a Preferred by Nature assessment team member during or shortly after the fieldwork.
- **2.** Call and give comments to Randy Coots, Preferred by Nature staff person responsible for coordinating this certification assessment. If Randy Coots is not in the office, please give your comments Karen Brenner.
- Submit written comments by mail, FAX or email to Preferred by Nature to Randy Coots. Unless you request
  otherwise, these comments will be kept confidential and are solely for the purpose of assessing the GCF US
  Holdings, LLC.

The source of any information provided will be kept confidential, available only to FSC and Preferred by Nature staff.
